About Air Ambulances IK

Air Ambulances UK (AAUK) is the national charity supporting the lifesaving work of the UK's air ambulance charities, enabling them to save even more lives every day.

Air ambulance crews bring the Emergency Department to patients who have suffered a life threatening or life changing trauma or medical emergency; providing advanced critical care to save lives.

On average an air ambulance can reach someone in urgent need within 15 minutes. Anyone, anywhere in the UK can become a patient at any time. Air ambulance charities are collectively dispatched to over 107 lifesaving missions each day across the UK; each mission is funded almost entirely by the generosity of local communities.

AAUK raises national funds to invest in the air ambulance community and acts as the voice on issues of national significance. Our vision is that together we will ensure the best possible chance of survival and patient outcome for everyone in need of lifesaving pre-hospital care. We do this by supporting and championing the invaluable work of the air ambulance community at a national level.



MEETINGS

The Board usually meets four to six times a year, sometimes virtually. The in person meetings take place at various Air Ambulance bases across the country. The People and Risk and Audit Committees' meetings take place virtually during the working day. In addition, the Chair will meet monthly with the CEO, it is anticipated that the new Chair will be able to commit to 2 to 3 days a month in total.

EXPENSES

The trustee role is unremunerated but reasonable travel, training and relevant other expenses will be covered.

Please note that our Governing Document states that an Independent Director (Trustee) must have had no involvement in (including acting as a trustee of or providing paid services to) an Air Ambulance Charity for at least one year prior to their appointment as a Director.

Chair Role Description

This is an exciting opportunity to contribute strategically to a charity dedicated to saving more lives across the UK.

We are looking for an individual, with previous charity Board experience, who shares our values, who will work with fellow trustees, and the CEO effectively to make a positive difference to patients.

Air Ambulances UK is looking for a strategic Chair who will take the time to understand the intricacies of our sector.

We are looking for someone who has time, is willing to challenge, ask difficult questions and constructively manage conflict whilst being equally willing to learn.

We want a Chair who strives for excellence and is excited by innovation without losing sight of the need to consistently get the basics right together with a focus and commitment to our core purpose.

MAIN DUTIES AND RESPONSIBILITIES;

- Ensuring that board decisions are made within the remit of the governing document and the policies of the Charity.
- Planning the annual cycle of board meetings, and chairing and facilitating these to ensure their smooth running.
- Planning the agenda for meetings with the CEO.
- Developing membership of the trustee board to ensure that it contains the diverse range of skills, experience and knowledge needed to operate effectively, with due consideration for community representation.
- Key posts are identified and inducted in good time.
- Ensuring that trustees receive induction and adequate training to enable them to fulfil their roles.
- Monitoring the calibre, level of commitment and attendance of all trustees and not be afraid to appropriately challenge where necessary.
- Ensuring that the board reviews its own work and how effectively it operates; making sure to take any corrective action required.
- Checking that decisions taken at meetings are being implemented.
- Ensuring that the board reviews the work of the charity.
- Liaising with the CEO to keep an overview of the Charity's business.
- Providing support and supervision for the CEO, including annual appraisal.
- Ensuring proper management and control of the Charity's finances.
- Representing the Charity at national events.

In addition to the above statutory duties, each Trustee should use any specific skills, knowledge or experience they have to help the Board of Trustees reach evidence-based decisions.

Main duties & responsibilities for all trustees

Each individual member of the trustee board has a responsibility to contribute to the discharging of the board's duties. They can do this by:

- Maintaining an awareness of the business of the Charity.
- Taking responsibility for their own learning and development.
- Attending, preparing for and taking a full part in meetings.
- Monitoring the financial position and ensuring that the Charity operates within its means and objects, and that there are clear lines of accountability for day-to-day financial management.
- Actively seeking to further the strategic objectives of the Charity, and acting in its best interests at all times.
- Maintaining confidentiality about any sensitive or confidential information received in the course of duties as a trustee.

AAUK is an inclusive organisation and strive to take on board different perspectives. We would encourage applications from people in the earlier stages of their careers and people from minority and other diverse communities. We are committed to treating all candidates equally regardless of sex, sexual orientation, marital status, age, disability, race, colour, ethnic or national origin, religion, political beliefs or membership or non-membership of a Trade Union and look forward to receiving applications from right across our communities.
